3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.

G KRITIS09: *Transcripts of Records will be issued by the Secretariat of the Receiving School and are provided directly to the sending institutions, no later than 5 weeks after the assessment period has finished at TUC.*

4. Termination of the agreement

The institutions decide in mutual agreement on the procedure of modifying or terminating the agreement. In the event of unilateral termination, a notice of at least one academic year has to be given.

The grading scale ranges from zero to ten (0 to 10) where, 0 is the lowest grade, 10 is the highest grade and five (5) is the minimum pass grade.

The ranking is as following: **EXCELLENT-A** (8.5 to 10), **VERY GOOD-B** (6.5 to 8.49), **GOOD-C** (5 to 6.49) and **FAIL-F** (0 to 4.99).


